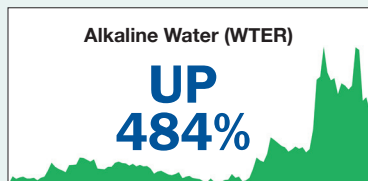

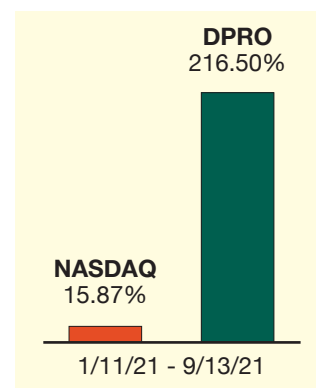

For example, in the wake of a natural

disaster — such as a hurricane, flood or fire — it can be difficult for first responders to assess the damage and provide aid to the areas with the greatest need.

Traditionally, fire and rescue squads have used satellites or manned aircraft to help map the devastation.

But those solutions can be slow to deploy, while drone technology can be more efficient and allows for higher-resolution imaging even in the most remote locations.

In Houston, Texas — when Hurricane Harvey struck, drones were deployed to assess damage to homes, roads, bridges, power lines, oil and gas facilities, and office buildings.

The drone footage helped officials monitor important levees, identify areas in danger of future flooding, and estimate how long certain areas would be underwater.

Recently, with Hurricane Ida slamming Louisiana, drones again assessed the damage and helped decide where help was most needed.

Better yet, drones can help improve response to just about any kind of disaster.

For example ...

"The Greatest Innovation in Firefighting This Year"

Over the last several years, North America has not only seen more devastating hurricanes, it has also suffered the effects of an increasing number of wildfires and brush fires — particularly in the West.

Recently, at least two dozen drones were used extensively by 30 pilots to fight wildfires in Oregon, California, Colorado and elsewhere — more than double the amount used in the previous year.

According to the U.S. Fire Administration, in one recent calendar year firefighters sustained 34 deaths and 29,760 injuries while combating fires.

Furthermore, because aircraft must fly at low altitudes to fight wildfires, pilots and crews are put in danger and made to endure high temperatures, low visibility, dangerous winds and high stress.

But drone technology is changing that in a

powerful way.

National Geographic reports that, "Because of their size and maneuverability, drones can access places that fixed-wing aircraft and helicopters can't, making them arguably *the greatest innovation in firefighting this year.*"

smoky and foggy for human-piloted aircraft.

- Drones outfitted with communication systems are able to sustain contact between the command center and firefighters on the ground.
- Larger drones can transport supplies where needed, while large numbers of smaller drones can be deployed to provide greater situational awareness when battling a blaze.
- Drones have been used to deploy small, incendiary devices to ignite small fires in critical locations, in order to rob an approaching large fire of the fuel it needs to spread.

In the winter of 2013, a car flipped over in a remote, wooded area in the Canadian province

of Saskatchewan.

First responders couldn't locate the crash victim — who had wandered away from the wreck — even with a helicopter using infrared equipment.

Then a Royal Canadian Mounted Police officer decided to deploy a Draganflyer drone with an infrared camera attached.

In just a few minutes, the drone helped police spot the injured driver, who was unresponsive and huddled near a snowbank.

Without the drone, police would have had to wait to start further search-and-rescue missions until the morning — and it's unlikely the driver would have survived.

Even the Smithsonian Was Impressed

As a result of this heroic rescue, the Draganflyer became the first drone to be inducted into the Smithsonian National Air & Space Museum.

The same combination of thermal imaging and Draganfly technology that saved that driver's life are now available to help assist with individual accident rescues and to provide needed emergency relief all over North America.

In fact, the company has designed a complete Draganflyer Commander Public Safety Drone Package to help public agencies and private enterprises protect life.

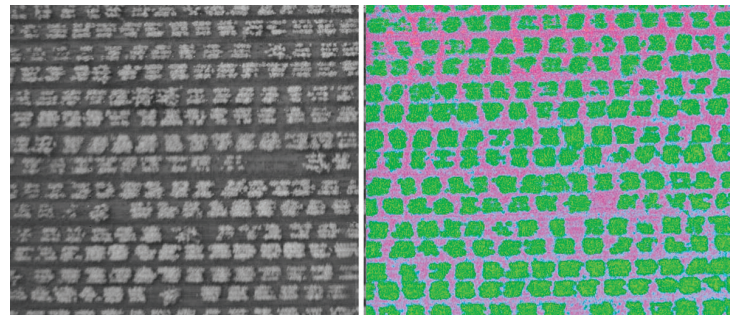

How Multispectral Imaging Allows Draganfly Drones to See What You Can't

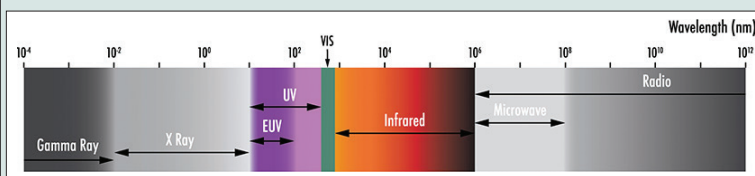
The human eye can only see things in the visible spectrum (shown in green on the accompanying graphic), ranging from approximately 400 nanometers to 700 nanometers.

Multispectral sensors, on the other hand, can detect things that lie outside the visible spectrum. A complex computer algorithm then converts what the sensor “sees” into a display in which each color represents something different.

Draganfly sensors can be configured to detect many things that can't be seen with the naked eye, including:

- Hairline cracks in aircraft
- Malfunctioning transformers in electrical grids
- Leaks in oil and gas pipelines
- Flow rate in water pipes

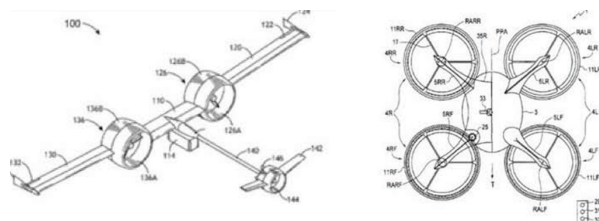

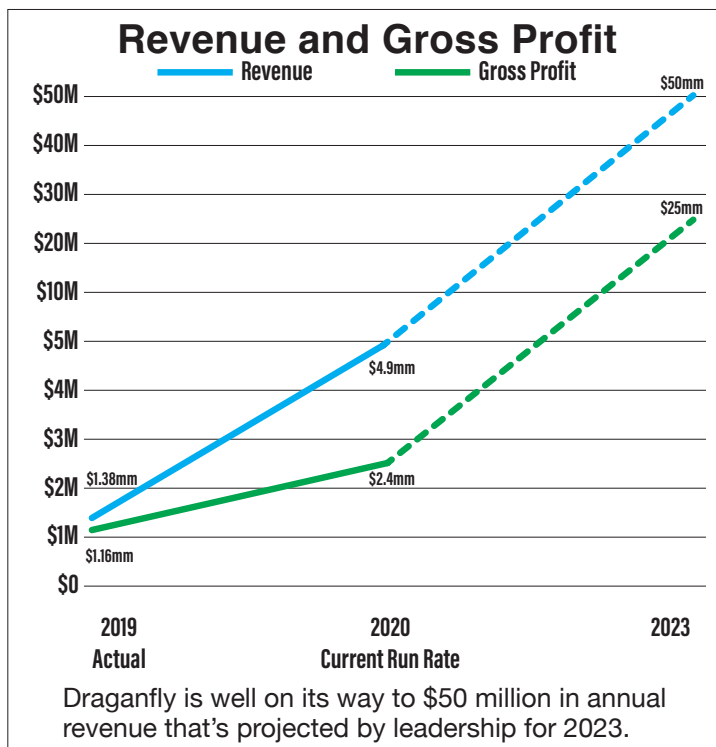

However, there's one more factor that could prove even more important ...

Uncle Sam: China, Take a Hike

Chinese firms, virtually all controlled directly or indirectly by the Chinese Communist Party, command approximately 80% of the drone market.

But not for long ...

Because of the risk of stolen data (see accompanying sidebar below), on June 10, 2019, President Trump determined that the “domestic production capability for small unmanned aerial systems is essential to the national defense.”

Since then, President Biden made it clear that he supports the ban on Chinese drones, stating we must shift production of critical products back to U.S. soil, thus “protecting U.S. supply chains against national security threats.”

Trump's presidential determination led to a flurry of actions throughout the federal government:

- The Secretary of the Interior issued Order

#3379 preventing Chinese-made drones from operating over federal lands.

- The Department of Defense initiated a program to ensure “secure, trusted, small unmanned aerial systems capability to the U.S. government.”
- The Commerce Department added DJI, the largest Chinese drone maker, to its ‘entity list,’ restricting DJI's access to US technologies and hobbling its supply chain.
- Legislation was introduced in both the House (the Drone Origin Security Enhancement Act) and the Senate (The American Security Drone Act) to restrict Chinese drones.

And recently, Secretary of State Antony Blinken is in full agreement, testifying before Congress that President Trump was “right in taking a tougher approach to China.”

All this is bad news for China, but good news for North American drone companies.

As I mentioned, China controls 80% of the drone market, but as the federal government cracks down on Chinese drones, it opens up new opportunities for U.S. companies. And, as you've seen, Draganfly is well positioned to capitalize

Biggest Chinese Threat: Stealing Your Data

Every minute a drone flies through the air, it's collecting data. It might be the location of utility lines, the amount of nutrients in a vineyard's soil, or locations where medical supplies are being delivered.

All this information is transmitted to the drone operator using WiFi or radio frequencies. But in the case of drones manufactured in China, this valuable information can also find its way into the hands of the communist Chinese government.

“The United States government has strong concerns about any technology product that takes American data into the territory of an authoritarian state that permits its intelligence services to have unfettered access to that data or otherwise abuses

that access.” — excerpted from Alert issued by the U.S. Dept. of Homeland Security

The Department of Homeland Security has warned that Chinese drones are targeting water utilities, railroads, and police departments.

Using that data, Communist China (or a terrorist organization acting as a proxy) could wreak havoc.

Additionally, DHS suspects the Chinese use this data to secure commercial advantages.

For example, after a California vineyard used a Chinese drone to monitor grape production, Chinese companies began purchasing vineyards in the same area.

DHS believes the Chinese companies used the data collected by that drone “to

contained predictions that turned out to be chillingly accurate.
